I, Amy Irani, declare as follows:

1

I am the Director of Environmental Health for Nevada County (the "County"). I
 have served in this position since January of 2015. In my capacity as Director of Environmental
 Health, I oversee Nevada County's Environmental Health Department (the "Department"), which
 is responsible for, among other things, ensuring that food service establishments located in the
 County comply with applicable regulations.

7 2. I make this declaration in support of the Nevada County Defendants' Motion for
8 Summary Judgment, or, in the Alternative, Summary Adjudication in this action. I have personal
9 knowledge of the facts set forth herein, except as to those stated on information and belief, and, as
10 to those, I am informed and believe them to be true. If called as a witness, I could and would
11 competently testify to the matters stated herein.

Between March 2020 and June 2021, the State of California and Nevada County
 issued and enforced various public health orders and restrictions to combat the spread of COVID 19 (the "Public Health Orders"). Certain of these Public Health Orders required that food service
 establishments – including those in the County – temporarily alter their operations. For example,
 at various times, restaurants were required to cease or limit onsite and/or indoor dining, large
 events, and live music, and were required to comply with masking and social distancing measures,
 as well as capacity restrictions.

19 4. The County endeavored to ensure that food service establishments located within 20 its boundaries complied with the Public Health Orders during this time period. The Department 21 spearheaded this compliance effort through a combination of education and outreach, as well as 22 enforcement measures where necessary. The goals of the County and Department were three-fold: 23 to assist in stopping the spread of COVID-19 throughout the County and State as a whole, to 24 ensure the safety of the County's citizens from this deadly virus, and to assist food service 25 establishments in developing and maintaining safe practices so that they could continue their business activities. 26

27
 5. In furtherance of these goals, the Department provided food service establishments
 28 with regular updates regarding the applicable requirements of the Public Health Orders as well as

guidance as to how to comply with same. The Department provided these updates and guidance
 via periodic emails to food service establishment owners as well as by dropping off informational
 packets at the food service establishments.

6. Throughout the time period when the Public Health Orders were in place, the
Department received complaints from the public that various food service establishments in the
County were not complying with the Public Health Orders. These complaints were received
through comments left by citizens on a public-facing web portal the County maintained that
allowed the public to register complaints, through telephone calls and voicemail messages left
with the Department, through emails or letters sent to the Department, or when citizens personally
came to the Department to voice their concerns.

7. 11 When such complaints were received, the Department attempted to gain voluntary 12 compliance from the restaurants at issue through such measures as contacting the restaurants to 13 inform them of the complaints, providing the restaurant owners with additional information about 14 the applicable requirements of the Public Health Orders, visiting the restaurants to ensure they 15 were meeting the requirements, and meeting with restaurant owners to provide education or 16 assistance to help the restaurants come into compliance. Because of the large number of food 17 service establishments in the County, the Department did not conduct inspections for compliance 18 with the Public Health Orders in the absence of citizen complaints.

19 8. Most restaurants found to be in violation of the Public Health Orders were willing 20 to work with the County to come into compliance with the requirements. For the few restaurants 21 that continued to violate the Public Health Orders after discussions with Department employees, 22 the Department issued Notices of Violation, and, in some cases, fines were imposed, closure 23 orders were issued, and permits were temporarily suspended, to prevent the restaurants from 24 continuing to endanger the health of County citizens. Plaintiffs Tuck's Restaurant and Bar 25 ("Tuck's Restaurant") and Buckman Enterprises, LLC d/b/a Old Town Café ("Old Town Café") 26 were some of the few food service establishments in the County that did not voluntarily comply 27 with the Public Health Orders.

9. 1 During the time period when the Public Health Orders were in place, the 2 Department received many complaints from citizens and other local businesses that Tuck's 3 Restaurant and Old Town Café were in violation of the Public Health Orders. After the State 4 issued a Public Health Order on July 13, 2020 requiring restaurants to limit in-person dining 5 services to outdoor seating, these complaints became particularly acute, and focused on the 6 restaurants' failure to close indoor dining as well as violations of masking requirements, social 7 distancing and capacity requirements, and the prohibition on live music indoors. Attached hereto 8 as **Exhibit 21** is a true and correct copy of a selection of complaints received by the Department 9 concerning Tuck's Restaurant's non-compliance with the Public Health Orders in July 2020. 10 Attached hereto as **Exhibit 22** is a true and correct copy of a selection of complaints received by 11 the Department concerning Old Town Café's non-compliance with the Public Health Orders in July 2020. 12

13 10. The Department investigated these complaints, and attempted on numerous 14 occasions to gain voluntary compliance. In particular, the Department contacted the restaurants by 15 email and/or telephone in July 2020 regarding these complaints and the restaurants' non-16 compliance with the Public Health Orders. Shortly after the July 13, 2020 order requiring 17 restaurants to close for indoor dining, I also visited Tuck's Restaurant and spoke with the owners 18 about the requirements of the Public Health Orders and the importance of compliance. 19 Additionally, the Department provided educational guidance packages to both Tuck's Restaurant 20 and Old Town Café containing information about the applicable requirements of the Public Health 21 Orders. Despite these efforts, however, both Tuck's Restaurant and Old Town Café continued to violate the Public Health Orders. 22

11. When the violations persisted, the Department issued Tuck's Restaurant and Old
 Town Café Notices of Violation and ordered their immediate closure to protect the County's
 citizens. On July 21, 2020, I visited both restaurants to deliver these Notices of Violation and
 closure orders. At the time of my visit, Old Town Café was allowing dine-in seating and was
 serving customers. I informed the owners of both restaurants that the Notices of Violation and
 closure orders were being issued because of their non-compliance with the Public Health Orders in

place at the time. Attached hereto as **Exhibit 23** is a true and correct copy of the July 21, 2020 1 2 Notice of Violation: Immediate Closure of Food Service Establishment Due to an Imminent 3 Health Hazard issued to Friar Tuck's, produced in this litigation as NEVADA-000889-000890. Attached hereto as **Exhibit 24** is a true and correct copy of the July 21, 2020 Notice of Violation: 4 5 Immediate Closure of Food Service Establishment Due to an Imminent Health Hazard issued to Old Town Café, produced in this litigation as NEVADA-000886-000887. Attached hereto as 6 7 **Exhibit 25** is a true and correct copy of the July 21, 2020 Closure Order issued to Friar Tuck's, 8 produced in this litigation as NEVADA-000965. Attached hereto as **Exhibit 26** is a true and 9 correct copy of the July 21, 2020 Closure Order issued to Old Town Café, produced in this 10 litigation as NEVADA-000966.

After Tuck's Restaurant and Old Town Café received the Notices of Violation and
 closure orders, the two restaurants continued to violate the Public Health Orders by providing
 indoor dining services and not complying with masking requirements. As a result, the Department
 imposed fines on the restaurants and suspended their permits.

15 13. The Department continued to work with both Friar Tuck's and Old Town Café on 16 their compliance issues after the fines were imposed and permits suspended. For example, the 17 Department called Tuck's Restaurant and Old Town Café and left messages for the owners to 18 reach out to the Department so that we could assist them in the process to reinstate their permits. 19 Additionally, the Department put together a document to assist the owners with updating their 20 operational plans to come into compliance with the Public Health Orders. Attached hereto as 21 **Exhibit 27** is a true and correct copy of a July 30, 2020 memorandum I prepared which describes 22 these outreach efforts as well as the process to reinstate the restaurants' permits, produced in this 23 litigation as NEVADA-000440. This process included the owners updating their operational plans 24 to include a description of how indoor dining would be discontinued and this discontinuation 25 would be maintained until the Public Health Order prohibiting indoor dining was lifted, as well as 26 a site inspection by the County to verify that the operational plan was in play and prohibited 27 indoor dining.

1 14. On July 29, 2020, I also sent an email to Tuck's Restaurant owner Ken Paige,
 outlining the specific steps the restaurant would need to take to come into compliance with the
 Public Health Orders, and stating that once compliance was achieved, the restaurant's permit
 could be reinstated and fines could be resolved. Attached hereto as <u>Exhibit 28</u> is a true and
 correct copy of an email chain containing this July 29, 2020 email to Ken Paige, produced in this
 litigation as NEVADA-001470-1472.

7 15. Additionally, on August 3, 2020, I attended a meeting with the owners of Tuck's 8 Restaurant and Old Town Café. I understood that the restaurant owners had requested to meet 9 with County officials to discuss their fines and permit suspensions. The attendees at the meeting 10 were Tuck's Restaurant owners Ken Paige and Chad Paige, along with Ken Paige's wife Donna Paige; Old Town Café's owner Robin Buckman and his wife Lisa Buckman; Steven Bailey, the 11 12 attorney for the restaurant owners; myself; and County Counsel Katharine Elliott. At the meeting, 13 County Counsel Elliott and I reiterated the importance of complying with the Public Health 14 Orders, and explained that if the restaurants committed to complying with the Public Health 15 Orders, their permits could be reinstated and their fines could be reduced. Tying such fine 16 reductions and permit reinstatement to compliance with the Public Health Orders accorded with 17 the County's and Department's goals of stopping the spread of COVID-19, ensuring the safety of 18 County citizens, and assisting food service establishments in developing and maintaining safe 19 business practices. Attached hereto as **Exhibit 29** is a true and correct copy of contemporaneous 20 notes I took of the August 3, 2020 meeting, produced in this litigation as NEVADA-000893-000896. 21

16. Based on the restaurants' representations that they would comply with the Public
Health Orders and their efforts to do so, the County reinstated their permits on August 4, 2020.
Attached hereto as <u>Exhibit 30</u> is a true and correct copy of the August 4, 2020 Notice:
Reinstatement of Operational Permit sent to Friar Tuck's, produced in this litigation as NEVADA000883. Attached hereto as <u>Exhibit 31</u> is a true and correct copy of the August 4, 2020 Notice:
Reinstatement of Operational Permit sent to Old Town Café, produced in this litigation as
NEVADA-000903.

17. 1 Prior to the reinstatement, on August 3, 2020, Tuck's Restaurant owner Ken Paige sent me an email in which he represented that the restaurant had ceased all dine-in operations and 2 3 provided a specific compliance plan as requested. Attached hereto as **Exhibit 28** is a true and 4 correct copy an email chain containing this August 3, 2020 email from Ken Paige, along with my 5 response on August 4, 2020, produced in this litigation as NEVADA-001470-1472. The County 6 subsequently inspected both restaurants and reviewed their compliance plans to ensure that the 7 restaurants were in compliance with the Public Health Orders. Attached hereto as **Exhibit 32** is a 8 true and correct copy of an August 4, 2020 email from Nevada County Environmental Health 9 Specialist II, Nicole Johnson, to Ken Paige, on which I am copied, referencing the inspection of 10 Tuck's Restaurant, produced in this litigation as NEVADA-001084.

11 18. The fines imposed on both restaurants were also subsequently reduced, based on
12 the restaurants' compliance commitment and efforts. Attached hereto as Exhibit 33 is a true and
13 correct copy of an April 22, 2021 letter I sent to Tuck's Restaurant discussing the reduction in that
14 restaurant's fines, produced in this litigation as NEVADA-000969-000970. Attached hereto as
15 Exhibit 34 is a true and correct copy of an April 22, 2021 letter I sent to Old Town Café
16 discussing the reduction in that restaurant's fines, produced in this litigation as NEVADA-00097117 000972. However, I am informed and believe that neither restaurant ever paid these reduced fines.

18 19. I am informed that, in this litigation, Plaintiffs claim that the County conditioned 19 the reinstitution of Tuck's Restaurant's and Old Town Café's permits and a reduction in the fines 20 imposed on the two restaurants on Plaintiffs' ceasing to oppose and/or encourage others to oppose 21 the Public Health Orders, including by writing letters to County officials expressing such 22 opposition. However, the Department's enforcement of the Public Health Orders with regard to 23 Tuck's Restaurant and Old Town Café, including the County's decision to reinstitute the two 24 restaurants' permits and reduce their fines if they committed to coming into compliance with the 25 Public Health Orders, was not in any way connected with Plaintiffs' opposition to the Public 26 Health Orders, and would have been the same regardless of whether or not Plaintiffs publicly 27 opposed the Public Health Orders and/or encouraged others to do so.

20. 1 As discussed in Paragraphs 4-8 above, the Department enforced the Public Health 2 Orders based on complaints it received from the public. The Department investigated such complaints, and, if violations were found, it endeavored to gain compliance from the restaurants at 3 4 issue. Penalties were imposed only on a few restaurants that repeatedly refused to comply with 5 the Public Health Orders. Enforcement activities were aimed at stopping the spread of COVID-19, and were unrelated to any opposition to the Public Health Orders. The Department's only goal 6 7 for agreeing to reinstate permits or reduce fines was to ensure compliance with the Public Health 8 Orders, and to assist restaurants in coming into compliance. If a restaurant committed to comply 9 with the Public Health Orders or took steps to comply, the County would reinstate its permit or 10 reduce its penalties.

Indeed, restaurants whose owners did *not* publicly oppose the Public Health Orders
 but violated the Public Health Orders were still the subject of enforcement efforts, and restaurants
 whose owners *did* publicly oppose the Public Health Orders yet still complied with the Public
 Health Orders were not the subject of enforcement efforts.

15 22. For example, one restaurant in the County, Calla Lily Crepes, repeatedly violated 16 the Public Health Orders and refused to come into compliance. The County issued a Notice of 17 Violation and closure order to Calla Lily Crepes due to its non-compliance with the Public Health 18 Orders. Due to the restaurant's continued refusal to comply with the Public Health Orders, the 19 County was eventually forced to get a court order to prevent the owner of that restaurant from 20 continuing to operate in violation of the Public Health Orders. I am informed and believe that the 21 owner of Calla Lily Crepes did not engage in any substantial public opposition to the Public 22 Health Orders or encourage others to do so.

23 23. Additionally, the owners of Maria's Mexican Restaurant in the County did engage
24 in public opposition of the Public Health Orders, but no enforcement action was taken by the
25 County with regard to that restaurant because it complied with the Public Health Orders.

26 24. Although Tuck's Restaurant and Old Town Café engaged in public opposition to
27 the Health Orders following the August 3, 2020 meeting, the Department never imposed fines on
28 Tuck's Restaurant or Old Town Café or suspended their permits at any time after the August 3,

1	2020 meeting, while the Public Health Orders were in place. Indeed, as discussed, the Department
2	reinstated their permits and reduced their fines because they committed to complying with the
3	Public Health Orders and took steps to implement their compliance plans.
4	25. Prior to the August 3, 2020 meeting, I was not aware that Plaintiffs had publicly
5	opposed the Public Health Orders or had encouraged others to do so. I was also not aware prior to
6	the August 3, 2020 meeting of Plaintiffs communicating with County officials or encouraging
7	others to communicate with County officials about their opposition to the Public Health Orders.
8	
9	I declare under penalty of perjury under the laws of the United States of America that the
10	foregoing is true and correct.

### July 30, 2020 EH Update on COVID -19 Related Activities

The EH Department's site visits today of Sergio's and Old Town Café found that both facilities have ceased dine-in operations. Each facility was utilizing outdoor operations and were still open. The Union article and interview of Ken Paige, owner of Friar Tucks, is being used as confirmation that Friar Tucks will also cease dinein operations.

At this time, the operational permits for each establishment still remain in a temporary suspension, which requires the facility to remain closed. The EH Department has not received any outreach from the facility operator(s), but calls were placed to the owner(s) of Sergio's, Old Town Café and Friar Tucks. Messages were left for the owner(s) to reach out to the EH Department so that we can assist them in the process moving forward towards re-instating their permits.

The process to re-instate will include:

- 1. The operator updating their current operational plan to include how the dine-in operations will be discontinued, and how they will maintain this discontinuation until the State Order is lifted.
- A Site Inspection will be conducted by the EH Department to verify that the operational plan as described is in play and prohibits dine-in operations. A site written inspection will be completed, and a copy given to the owner/operator for their records.
- 3. The penalty/fines paid in full.

The EH Department has put together a document to assist the owner with updating their operational plan and to make the process simple and uncomplicated. Once the items are completed, the permit will be reinstated immediately.

We will lock the dining entrance with no public access and plan to stage our outside musicians in front of this door therefore no possible entry at all.

The bar entrance will be open with no table at all. The bar area will be our Take-out entrance and it will be our bartenders & Servers door to deliver drinks and food to our outdoor customers on the street

We have no need to put the chairs on the tables as our dining area are booths and there is zero access to patrons.

We have no need to put the chairs on the table in the bar as there will be none in this area.

Our **plan for take out** is the same as the prior plan. Customers can call or do on-line orders. They have the opportunity to request curbside delivery or pick up inside.

We can accommodate either. Customers who prefer inside pick up will come into the bar area and stand and wait to get their order. Customers who want curbside delivery will park on Commercial street & Since the streets are closed off we will stage the outside pick up on commercial street. We will not offer Alcohol to go.

Out outside dining has already been approved by the city with 10 tables on the street where we will provide some light barrier distinction so

the community is aware of the Friar Tucks area where we have reserved seating and alcohol. We will also have 4 table set up against the Building that can

accommodate an additional 8 guests.

Steven Bailey (attorney); Friar Tucks owners: Ken, Donna and Chad Paige; Old Town Café Owners: Lisa & Robin Buckman Kit Elliott (CoCo) Amy Irani, EHD

### Notes:

Meeting started at 1pm. Kit did introductions and informed everyone that the County is grateful for everyone coming in to meet with the County. Spoke briefly about the Care funding and \$3M going out to assist the community. In contact with Counties and discussions, and our Board's desire to understand the economic impact. Those businesses operating outside of the rules, when others are operating within the rules or guidelines, there should be accountability for the community.

Amy: Talked about the working with city entities to create outdoor dining; and looking for resolutions for facilities to continue operations w/the restrictions.

Steven Bailey talked about being thankful for the County to have this meeting. It is not suitable for outdoor seating with it being 102F on the asphalt and then when the weather changes, will not have outdoor capabilities with dining outside. Appreciate everything you have done, and my clients appreciate it as well. But need to come up with an alternative.

Need to address 2 items right now. The closure and the tolling of the closure orders. Want the removal of the closure orders, and our clients agree that they will maintain the closure of the dine-in operations. Friar Tucks have gone out an created some cutting-edge technology with the air quality and brought material to look at the system. Ionization of the air, and the technology that is affordable. The County could use the Cares act monies for to retrofit the establishments with this system. Wants to keep the discussion going so that we can continue to solve the problem and this problem needs to be solved statewide. Can tell us that not all of the restaurants are closed in the Counties across the State.

Kit stated that the Cities are closed.

Steven Bailey: Yes, agreed, Cities but Counties are not closed. Nevada County should be the leader as we are not on the watch list. In terms of the current situation of the closure orders, can we do something about them right now?

Kit – 2 things; when I spoke with you – we need the plan; from the operator.

Steven Bailey: we write them up right now, then the closure is over and there should be waiving of any fines. Friar Tucks to open right away.

Kit: explained that we could 'stay' the violations to hold the fines for 30 days; this would allow EH to inspect and open up as quickly as possible.

Steven Bailey: stated that he wants the facilities to open right now.

Amy: explained that there are fines for the operation w/out a permit that continued with Old Town. Friar Tucks closed per the closure requirement.

Kit: indicated that there could be a stay of the fines and have to make sure that the establishments are compliant. But there has to be a penalty with the act of not complying with the Governor's Order.

Chad Paige: indicated that we were all trying to send a message, as we didn't think the Governor's message in a broad stroke was good for our County.

Kit: explained that we are stuck with the Governor's order, and we are working with our State partners.

Steven Bailey: believes that there is a great amount of discretion now, that Counties can choose how to operate despite the Governor's Order.

Kit: stated but not about indoor dining.

S. Bailey: at this moment right now want Old Town Café open and Friar Tucks open right now.

Kit: explained that she needs to talk to the Board, and to discuss the process of staying payment of the fines. If everyone complies, then would be willing to stay the fines for the next 30 days.

Robin Buckman: stated "we were not being defiant and did not close to be a butthead, we barely survived the 60 days from the first shutdown. We have to put food on the table, and we have medical bills."

Kit: appreciated the sentiment from Old Town Café. Understand the issues with restaurants as have friends that own restaurants, and we do not want to just waive the fees, have to show a willingness to comply.

Ken Paige: "I agreed with the first round, and as the information came out, it was a slap in the face to hear about the shut down again. It wasn't anger, it was something in our gut, that said its much more than complying. Anyone can comply. The reality is how much does Friar Tucks want to invest in something that bleeds out in two months? When we say comply, we say how much to I want to take out of my retirement plan? Yes, I'll do it for the community, but if I do not see a purpose, why bleed out? I have to count the cost. If the government or County announced today that they are cutting government both your paychecks by 75% - now what are you going to say? How much am I willing to invest my own for this community? Why take the equity out of my home? This is Nevada City, human beings, houses, has to do with our heart and our community. Human beings in the same room here, this has to be about having a heart that is bigger than money or our jobs, and we have to get on the humanity side. Not about us complying. Its about us saying is there a Heart in this community? We will not be overrun by outside influences, consider where we are, if we want to stay at Friar Tucks, to believe what you are telling us, that you are going to do the right thing for us. Talking about the Heart of our community. If I do not hear that from the government, then we need to decide if we close our doors".

Kit: The reason we have had only 1 death, is that there is an amazing team that is keeping the community safe and keep us in the current variance. If I do not help us to enforce this law, and we lose the variance, now we are going to have to shut down hair salons, etc. I hear every day about what this looks like, what the numbers are, where they are coming from. As CoCo I cannot have an opinion. We want our businesses to succeed; moved here for the arts, the music, the area. I hear the backstory, speaking to the physicians and getting medicine to the people that need it. It's important to understand the balance.

Steven Bailey: "Ken talk briefly about the filtration system that he has put in. The idea is that what we are doing today cannot be sustained and is not uniform statewide. Nevada Co is more restrictive than San Diego County. We want to leave the meeting today with not just staying the fines and we are open we need to know that there is a way forward and work on a solution. If there is a solution that is available today that will address the concerns that EH has, then consider this system".

Steven requested meeting with Alison Lehman.

Kit: wants a stay of the fines and then EH would then need to rescind the current closure notice. Once the updated plan is in, EH Staff will inspect and photograph the seating area and the owner needs to designate the To-Go areas.

Meeting adjourned at 2:05pm.

Kit introduces herself and thanks everyone for being present today, we are here to find a solution and here to come to an agreement.

Kit wanted me to speak about the Vegas Firefly incident.

Amy: talked about legal ramifications from illnesses that result in a food facility – MarlerClark.

Kit emphasized that even the County has to have a plan in place to ensure that we are keeping our staff safe.

Yelena said that this is not what was told to us; that we asked Nicole what would happen legally if we got sued, and Nicole told us that we would need to consult with an attorney.

Amy: that is correct, she guided you correctly to contact an attorney that is what I would have told you.

Gregg Lien: stated to Yelena that he could help with the legal aspects.

Sergio: spoke and stated that they stayed open and continued dine-in operations. And we did not close immediately, and we were told we had to close, and we only had one day's notice and we decided to close.

Kit – what we want to get you back to up and running. We need you to update your plan going forward and re-open without dine-in operations.

Sergio: "Do we have local representation? I do not want to kill anyone, myself my staff my wife. Not doing this for the dollar, the dollar yes, it helps. I'm doing it because I feel oppressed and it hurts because this is America. And I should not feel oppressed because this is America. Because this is oppression and the Governor has oppression. And the Governor should say that we do not have an issue." Kit – there are 2 pieces to that. 1 you have the public health officers that are independent from the politicians, in order to protect people. Protecting people can feel like oppression. I am speaking regularly to our PH officer in order to keep the variance that we have from the State. We have done training, have isolated, PH has hired staff, and bringing the people who are isolated food. It is very complex and intense. It is a ball that is rolling and even though our #s are good, we are on the verge of the variance over. Then we are shutting down the salons, and other things that are open. We do not want to see this happen. The other piece is that we are not keeping everyone from getting sick, it is keeping people from getting sick and dying because the County does not have the resources to help them. Our PH officer and our PH Director have gone to the ends of the earth to help patients recover. We can't keep everyone safe, and it would be devastating to not be able to treat our sick.

Yelena "I'm an immigrant, got my naturalization, paid my fees and never asked for handouts. Sergio celebrated 45 years in America. I have almost 15 years as a citizen. I pay our bills we pay our taxes. Never had late fees. We didn't ask the County to take care of us or the Governor to take care of us. I am a responsible citizen. I do not understand why someone comes and dictates how I should organize in my house how I do anything. Homeless areas and situation, Brunswick basin. How about that, what about the homeless. Another part, no one is bringing up cures. All phase air conditioning has as system, we are willing to install the ultraviolet air systems to help. My Mother has worked in the surgery department in the Ukraine, and when I was 5 years old, they implemented the UV lights. In surgery they would turn on the UV lights, turn it on and kills on the viruses; we can do something like this. There are a lot of cures. Why do we have to shut up the economy? When we first closed, everyone was crying, psychological effects".

Kit – as a county we have an amazing group of people helping. The BOS created a fund to get monies out to the businesses.

Sergio – "we appreciate that we are here, and you all are under tremendous pressures, from the business side and the medical institutions. In the beginning, was Dr. Fauci said do not go to the hospital, but then we had to protect ourselves. Why not come up with a solution, and now I have become a rebel and it is not where I want to be. I am risking my health, and my retirement and my wife's health. I do not see a national level of effort of officials to solve the problem right away so there are not so many unintended consequences. The destruction of lives, families and if we do not have financial resources, we will also be in trouble and my point is with what I am reading and doctors that have been in business for many years. Hydroxychloroquine and zinc, so I do not understand that there is not an interest here, these cures work."

Kit: I hear what you are saying. I get it. We are both law enforcers we are not policy makers (speaking about me and her). I am here to discuss your business moving forward. Your community right now, is saying to us, why aren't you doing more to make people come into compliance.

Lena and Sergio stated this is not correct. They are scared.

Kit: the question I am trying to come back to. Right now, we have the Governor's order which is the law. We do not have choices. We understand that you have shut down your interior operations. We want to move forward, to understand a plan that will cover the current mandate. Right now, we have fines for operating w/out a permit. What we are prepared to do, to get through this, would agree with your attorney – to stay the fees for 30 days. Not removing the penalties/fines now.

At the end of 30 days, we will come back to have the discussion if you are doing everything okay, then would negotiate the fees being 3x the Annual permit fees. So that we can do this as quickly as possible, we will 'stay' the fines based upon operating w/out a permit. If you are prepared to go forward w/out the indoor dining and EH needs to confirm and will send Gregg an email with the fines.

Yelena – "Amy it is your fault that we lost the contract with the plates program, you made us lose \$85,000, you punched me in the stomach, and it was wrong. It is your fault that we lost the money."

Kit- it is not Amy's fault, it is not under her control it is a Public Health program and grant, Amy had nothing to do with it.

Yelena – "Yes she did, it is her fault. It is all her fault."

Gregg – back on the topic, so we can meet again maybe with our doctors to talk about cures.

Kit – adjourned the meeting at 3pm.
